THIS IS A RELEASE OF YOUR RIGHTS TO SUE *PLANET OCEAN*, *PDIC INT'L* AND *KENNETH A. CALDWELL* NOR, \_\_\_\_\_ AND HIS/HER EMPLOYEES, AGENTS AND (Instructor, Assistant Instructor, Dive Supervisors) ASSIGNS FOR PERSONAL INJURIES OR WRONGFUL DEATH THAT MAY OCCUR DURING THE FORTHCOMING DIVE ACTIVITY AS A RESULT OF THE INHERENT RISKS ASSOCIATED WITH SCUBA DIVING/SNORKELING OR AS A RESULT OF NEGLIGENCE.

- \_\_\_\_\_ 3.) I agree to stay together with my assigned dive buddy during all training and open water exercises.
- \_\_\_\_\_ 4.) I affirm that I am in good mental and physical fitness for diving, and that I am not and will not be under the influence of alcohol, nor am I under the influence of any drugs that are contradictory to diving. If I am taking medication, I affirm that I have seen a physician and have approval to dive while under the influence of the medication drugs.
- \_\_\_\_\_ 5.) I will inspect all of my equipment prior to the activity and will notify the above listed individuals if any of my equipment is not working properly. I will not hold the above listed individuals responsible for my failure to inspect my equipment prior to diving.
- \_\_\_\_\_ 6.) I acknowledge that I am physically fit to scuba dive/snorkel, and I will not hold the above listed individuals responsible if I am injured as a result of heart, lung, ear or circulatory problems or other illnesses that occur while diving and/or snorkeling.
- \_\_\_\_\_ 7.) I understand that even though I follow all of the appropriate dive practices, there is still some risk of my sustaining decompression sickness, embolism or other hyperbaric injuries, and I expressly assume the risk of said injuries.
- \_\_\_\_\_ 8.) I am aware of the dangers of breath holding while scuba diving, and I will not hold the above listed individuals responsible if I am injured doing so.
- \_\_\_\_\_ 9.) I also understand that scuba diving/snorkeling is a physically strenuous activity and that I will be exerting myself during the diving excursion, and then if I am injured as a result of heart attack, panic, hyperventilation, etc. that I expressly assume the risk of said injuries and that I will not hold the above listed individuals responsible for the same.
